This contract and agreement made and entered into this 17<sup>th</sup> day of April 2017 at Calapan City, Oriental Mindoro by and between

The **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, a local government unit with office address at Camilmil, Calapan City represented herein by **ALFONSO V. UMALI, JR.** in the capacity as Provincial Governor, hereinafter referred to as the PGOM.

And

The **Pakyaw Labor Group** represented by **ERNESTO SARDALLA** residing at **Calapan City, Oriental Mindoro** who has been authorized for this purpose in the capacity as Pakyaw Labor Group Leader, hereinafter referred to as the Pakyaw Labor Group.

**WITNESSETH**

**WHEREAS**, the PGOM has advertised a Notice of Invitation to Bid for Pakyaw Labor in the prosecution of this project with the ABC of **215,000.00**;

**WHEREAS**, the Pakyaw Labor Group has offered the lowest and most advantageous proposal to the government in the amount of **TWO HUNDRED TWELVE THOUSAND ONE HUNDRED NINETY PESOS AND 58/100 (Php 212,190.58)**;

**WHEREAS**, the PGOM awarded the contract of labor for the **Repair of Bahay Kanlungan & Completion of Fence at Brgy. Libis, Calapan City, Oriental Mindoro** to Pakyaw Labor Group in the amount of **TWO HUNDRED TWELVE THOUSAND ONE HUNDRED NINETY PESOS AND 58/100 (Php 212,190.58)**;

**WHEREAS**, the Pakyaw Labor Group agreed and accepted the award to undertake the Pakyaw Labor for the said project in the amount of **TWO HUNDRED TWELVE THOUSAND ONE HUNDRED NINETY PESOS AND 58/100 (Php 212,190.58)**;

**NOW, THEREFORE**, for and in consideration of the sum of **TWO HUNDRED TWELVE THOUSAND ONE HUNDRED NINETY PESOS AND 58/100 (Php 212,190.58)** to be paid by the PGOM to the Pakyaw Labor Group, the PARTIES hereto have agreed as follows;

1. That the Pakyaw Labor Group shall furnish labor only necessary for the proper and faithful performance in the prosecution of the project **Repair of Bahay Kanlungan & Completion of Fence at Brgy. Libis, Calapan City, Oriental Mindoro**.
2. That the description of work to be undertaken shall include **Improvement of Bahay Kalungan & Completion of Fence** and details of Scope of Work is provided hereunder;
