CONTRACT AGREEMENT

THIS AGREEMENT, made this NOV 11 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MARTINEZ ENTERPRISES with office address Lumangbayan, Calapan City, Oriental Mindoro represented by LYN A. MARTINEZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Barangay Market at Pulantubig, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FIVE HUNDRED NINETY SIX THOUSAND FIVE HUNDRED EIGHTY PESOS ONLY (Php 596,580.00) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
