WHEREAS, there is a purchase request submitted to the BAC for the procurement of **Supply & Delivery of Information Technology Parts and Accessories & Perip for use of Language Skills Institute;**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. GS-2021-156) in PhilGEPS Website on **November 4, 2021** and posted in the Provincial Capitol Complex, Bulletin Board Camilmil, Calapan City on even date for the **Supply & Delivery of Information Technology Parts and Accessories & Perip for use of Language Skills Institute;**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder** purchased corresponding bid documents;

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at **2:00 p.m of November 11, 2021**, the proceeding was in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;

WHEREAS, the detailed evaluation and comparison of bids conducted on **November 11, 2021** found out that bid price of **BLOOMING QUAILS OFFICE SUPPLIES TRADING** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Responsive Bid;**

WHEREAS, upon careful examination, validation and verification of eligibility, technical and financial requirements submitted **BLOOMING QUAILS OFFICE SUPPLIES TRADING** with **Single Calculated Responsive Bid**, its bid passed the post qualification process conducted on **November 16, 2021**, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **November 17, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:

a) To declare **BLOOMING QUAILS OFFICE SUPPLIES TRADING** with business address at **Sto. Niño, Calapan City, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.

b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **BLOOMING QUAILS OFFICE SUPPLIES TRADING** for **Supply & Delivery of Information Technology Parts and Accessories & Perip** for use of **Language Skills Institute** at a contract price equivalent to **THREE HUNDRED EIGHTEEN THOUSAND SIX HUNDRED PESOS ONLY (Php 318,600.00)**.

c) To recommend to **HUMERLITO A. DOLOR, MPA, PhD**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with **Single Calculated Responsive Bid**.
