CONTRACT AGREEMENT

MSSSD No. 178

THIS AGREEMENT, entered into this 12th day of November 2019 between the PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, PhD. Provincial Governor hereinafter called the "FIRST PARTY" and KAMAYAN PENTHOUSE BEACH RESORT with office address at Roxas, Oriental Mindoro represented by MS. PRINCESS DE GUZMAN, General Manager hereinafter called the "SECOND PARTY".

WHERE AS, the FIRST PARTY is desirous that the SECOND PARTY will provide the packaged deal (venue/accommodation/meals and snacks) to be served during the conduct of Mental Health and Psychosocial support during crisis, emergencies and disaster training on November 20-22, 2019 at Roxas, Oriental Mindoro in the amount TWO HUNDRED FIFTY THREE THOUSAND SEVEN HUNDRED FIFTY PESOS (Php 253,750.00) with the following agreement as follows:

- 1. That the Second Party will provide necessary facilities for the packaged deal (venue/accommodation/meals and snacks) to be served during the conduct of Mental Health and Psychosocial support during crisis, emergencies and disaster training on November 20-22, 2019 at Roxas, Oriental Mindoro, for the Province of Oriental Mindoro.
2. That the FIRST PARTY will pay the amount of Two Hundred Fifty Three thousand Seven Hundred Fifty Pesos (Php 253,750.00) from the Special Purpose Appropriation, Disaster Risk Reduction and Management Services, Preparedness, Strengthening of LDRRMO's & other DRRM partners/stakeholders in the province, Capability Development for stakeholders and service providers, Training Expenses of PGO-PDRRMO..
3. That the SECOND PARTY will be the one to shoulder all expenses in terms of packaged deal (venue/accommodation/meals and snacks) to be served during the conduct of Mental Health and Psychosocial support during crisis, emergencies and disaster training on November 20-22, 2019 at Roxas, Oriental Mindoro, to be incurred during the pendency of the contract.
4. That in case of breakdown of facilities in the aforementioned date and event the SECOND PARTY will be the one to shoulder the cost of repair expenses without any additional charge from the FIRST PARTY for this purpose.
