This contract and agreement made and entered into this 10th day of **December 2019** at Calapan City, Oriental Mindoro by and between

The **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, a local government unit with office address at Camilmil, Calapan City represented herein by **HUMERLITO A. DOLOR, MPA, PhD** in the capacity as Provincial Governor, hereinafter referred to as the PGOM.

and

The **Pakyaw Labor Group** represented by **JEFFRIE DE CASTRO** residing at **Calapan City, Oriental Mindoro** who has been authorized for this purpose in the capacity as Pakyaw Labor Group Leader, hereinafter referred to as the Pakyaw Labor Group.

WITNESSETH

WHEREAS, the PGOM has advertised a Notice of Invitation to Bid for Pakyaw Labor in the prosecution of this project with the ABC of **Php 358,700.00**;

WHEREAS, the Pakyaw Labor Group has offered the lowest and most advantageous proposal to the government in the amount of **THREE HUNDRED FIFTY EIGHT THOUSAND FOUR HUNDRED FIFTY PESOS ONLY (Php 358,450.00)**;

WHEREAS, the PGOM awarded the contract of labor for the Repair/Rehabilitation of Government Offices/Facilities at Capitol Complex Camilmil, Calapan City Oriental Mindoro to Pakyaw Labor Group in the amount of **of THREE HUNDRED FIFTY EIGHT THOUSAND FOUR HUNDRED FIFTY PESOS ONLY (Php 358,450.00)**;

WHEREAS, the Pakyaw Labor Group agreed and accepted the award to undertake the Pakyaw Labor for the said project in the amount of **THREE HUNDRED FIFTY EIGHT THOUSAND FOUR HUNDRED FIFTY PESOS ONLY (Php 358,450.00)**;

NOW, THEREFORE, for and in consideration of the sum of **THREE HUNDRED FIFTY EIGHT THOUSAND FOUR HUNDRED FIFTY PESOS ONLY (Php 358,450.00)** to be paid by the PGOM to the Pakyaw Labor Group, the PARTIES hereto have agreed as follows;

1. That the Pakyaw Labor Group shall furnish labor only necessary for the proper and faithful performance in the prosecution of the project Repair/Rehabilitation of Government Offices/Facilities at Capitol Complex Camilmil, Calapan City Oriental Mindoro.
