CONTRACT AGREEMENT

THIS AGREEMENT, entered into this 7th day of October, 2019 between the PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, PhD., Provincial Governor hereinafter called the "FIRST PARTY" and VENCIO'S GARDEN HOTEL & RESTAURANT with office address at Tawiran, Calapan City, Oriental Mindoro represented by MS. MAYVEL ORTEGA, Manager, hereinafter called the "SECOND PARTY".

WHEREAS, the FIRST PARTY is desirous that the SECOND PARTY will provide the catering services/accommodation and venue rental to be used/served during the conduct of Assessment Meeting and project Status Reporting on PRDP sub projects and Small Livelihood projects on octobe 9 & 10, 2019 at Calapan City, Oriental Mindoro in the amount of FIFTY FIVE THOUSAND THREE HUNDRED PESOS (Php 55,300.00) with the following agreement as follows:

- 1. That the Second Party will provide necessary facilities for the catering services/accommodation and venue rental to be used/served during the conduct of Assessment Meeting and project Status Reporting on PRDP sub projects and Small Livelihood projects on octobe 9 & 10, 2019 at Calapan City for the Province of Oriental Mindoro.
2. That the FIRST PARTY will pay the amount of Fifty Five Thousand Three Hundred Pesos (Php 55,300.00) from the Operations, Enterprise Development Services, Investment Promotion Services, Representation and rent Expenses.
3. That the SECOND PARTY will be the one to shoulder all expenses in terms of the catering services/accommodation and venue rental to be used/served during the conduct of Assessment Meeting and project Status Reporting on PRDP sub projects and Small Livelihood projects on octobe 9 & 10, 2019 at Calapan City, Or. Mindoro to be incurred during the pendency of the contract.
4. That in case of breakdown of facilities in the aforementioned date and event the SECOND PARTY will be the one to shoulder the cost of repair expenses without any additional charge from the FIRST PARTY for this purpose.
