CONTRACT AGREEMENT

THIS AGREEMENT, entered into this 4th day of February 2020 between the PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, PHD, Provincial Governor hereinafter called the "FIRST PARTY" and EDUARDO'S RESORT CORPORATION with office address at Tawiran, Calapan City, Oriental Mindoro represented by MR. ELIZALDE M. HERRERA, President, hereinafter called the "SECOND PARTY".

WHEREAS, the FIRST PARTY is desirous that the SECOND PARTY will provide the Accommodation to be used during the Video Shoot for GMA News TV's "PINAS SARAP" on February 7-13, 2020 at various Municipalities in Oriental Mindoro in the amount of SEVENTY ONE THOUSAND FIVE HUNDRED PESOS (Php 71,500.00) with the following agreement as follows:

1. That the Second Party will provide necessary facilities for the Accommodation to be used during the Video Shoot for GMA News TV's "PINAS SARAP" on February 7-13, 2020 at various Municipalities in Oriental Mindoro for the Province of Oriental Mindoro.
2. That the FIRST PARTY will pay the amount of Seventy One Thousand Five Hundred Pesos (Php 71,500.00) from the Operations, Tourism Development & Promotion Services, Tourism Development & Promotion, and Representation Expenses of PTIEDO.
3. That the SECOND PARTY will be the one to shoulder all expenses in terms of Accommodation to be used during the Video Shoot for GMA News TV's "PINAS SARAP" on February 7-13, 2020 at various Municipalities in Oriental Mindoro to be incurred during the pendency of the contract.
4. That in case of breakdown of facilities in the aforementioned date and event the SECOND PARTY will be the one to shoulder the cost of repair expenses without any additional charge from the FIRST PARTY for this purpose.
