CONTRACT AGREEMENT

MSSSD No. 39

THIS AGREEMENT, entered into this 30th day of August 2019 between the PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camiimil, Calapan City, Oriental Mindoro, represented by HUMERLITO A DOLOR, MPA PHD, Provincial Governor hereinafter called the "FIRST PARTY" and FERAREN HILLS RESORT with office address at Lumangbayan, Calapan City, Oriental Mindoro represented by MS. MA. CARINA A. ROMERO, Officer in Charge, hereinafter called the "SECOND PARTY".

WHERE AS, the FIRST PARTY is desirous that the SECOND PARTY will provide the accommodation to be used High Angle Rope and Rescue Training with Standard First Aid Technique and Basic Life Support on September 2-6, 2019 at Calapan City, Oriental Mindoro in the amount SEVENTY TWO THOUSAND NINE HUNDRED PESOS (Php 72,900.00) with the following agreement as follows:

- 1. That the Second Party will provide necessary facilities for the accommodation to be used High Angle Rope and Rescue Training with Standard First Aid Technique and Basic Life Support on September 2-6, 2019 at Calapan City, Oriental Mindoro, for the Province of Oriental Mindoro.
2. That the FIRST PARTY will pay the amount of Seventy Two Thousand Nine Hundred Pesos (Php 72,900.00) from the Disaster Risk Reduction and Management Services Preparedness, Strengthening of LDRRMOs & other DRRM partners/stakeholders in the province, capability development for stakeholders and service providers and training expenses of PDRRMO.
3. That the SECOND PARTY will be the one to shoulder all expenses in terms of accommodation to be used High Angle Rope and Rescue Training with Standard First Aid Technique and Basic Life Support on September 2-6, 2019 at Calapan City, Oriental Mindoro, to be incurred during the pendency of the contract.
4. That in case of breakdown of facilities in the aforementioned date and event the SECOND PARTY will be the one to shoulder the cost of repair expenses without any additional charge from the FIRST PARTY for this purpose.
