CONTRACT AGREEMENT

THIS AGREEMENT, entered into this 20th day of November 2019 between the PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, PHD., Provincial Governor hereinafter called the "FIRST PARTY" and EL PUEBLO RHIZORT CAL. INC with office address at Calapan City, Oriental Mindoro represented by MS. LIEZEL P. ZAMORA, Operation Manager hereinafter called the "SECOND PARTY".

WHERE AS, the FIRST PARTY is desirous that the SECOND PARTY will provide the Catering services with accommodation to be used during Training on Capacity Building for Coral-Reef Assessment and Coral Taxonomy (CRACT) on November 26-28, 2019 at Calapan City, Oriental Mindoro in the amount NINETY THOUSAND PESOS (Php 90,000.00) with the following agreement as follows:

1. That the Second Party will provide necessary facilities for the Catering services with accommodation to be used during Training on Capacity Building for Coral-Reef Assessment and Coral Taxonomy (CRACT) on November 26-28, 2019 at Calapan City, Oriental Mindoro, for the Province of Oriental Mindoro.
2. That the FIRST PARTY will pay the amount of Ninety Thousand Pesos (Php 90,000.00) from the Agricultural Services, Operations, Fisheries and Coastal Resources Development Program, Ecosystem Approach to Fisheries Management and Training Expenses.
3. That the SECOND PARTY will be the one to shoulder all expenses in terms of Catering services with accommodation to be used during Training on Capacity Building for Coral-Reef Assessment and Coral Taxonomy (CRACT) on November 26-28, 2019 at Calapan City, Oriental Mindoro, to be incurred during the pendency of the contract.
4. That in case of breakdown of facilities in the aforementioned date and event the SECOND PARTY will be the one to shoulder the cost of repair expenses without any additional charge from the FIRST PARTY for this purpose.
