


3. That the project shall be undertaken by the Pakyaw Labor Group in accordance with plans, specifications, program of work which are hereto attached and made integral part of this contract.

7. That the notarial expenses, Bid and performance security and other incidental expenses to be incurred in the execution of this project shall be borne by the Pakyaw Labor Group.






