



**BAC RESOLUTION RECOMMENDING TO THE HOPE THE AWARD OF  
 INFRASTRUCTURE CONTRACT**

**Resolution No. 052, Series of 2020**

**WHEREAS**, there is an infrastructure project funded through the **Supplemental Budget No. 2 for FY 2020** to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair/Rehab of Old Provincial Hospital Main Ward Building (Designated Quarantine Area) for COVID-19 Patients and PUI's/PUM's at Ilaya, Calapan City, Oriental Mindoro (1.) Installation of Drywall Partitions; 2.) Fab./ Installation of Double Deck; 3.) Installation of Laboratory Sinks; 4.) Installation of Electrical Lightings & Fans);**

**WHEREAS**, **GPPB Circular 01-2020** allows the BAC to negotiate with contractors with proven legal, technical and financial capacity to undertake procurement of infrastructure projects through Negotiated Procurement (Emergency Cases);

**WHEREAS**, during negotiations, **SANLAHI GROUP OF BUILDERS, INC.** has submitted a formal written offer (Bill of Quantities) for the above mentioned project in the amount of **ONE MILLION NINE HUNDRED EIGHTY THOUSAND FOUR HUNDRED FIFTY EIGHT PESOS AND 15/100 (Php 1,980,458.15)** and duly executed OSS For Emergency Procurement under Republic Act No. 11469 otherwise known as the "Bayanihan to Heal as One Act";

**WHEREAS**, **GPPB Circular 01-2020**, allows the BAC to immediately recommend award of contract to one that has legal, technical, and financial capacity to undertake the construction of the aforementioned infrastructure project;

**WHEREAS**, **GPPB Circular 01-2020**, allows the submission of mandatory documents after award of contract, but before payment;

**WHEREAS**, **SANLAHI GROUP OF BUILDERS, INC.** is a contractor known to possess legal, technical, and financial capacity to undertake the construction of the aforementioned project at the soonest possible time;

**NOW, THEREFORE, BE IT RESOLVED**, as it is hereby **RESOLVED**:

a) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro to award the aforementioned project to **SANLAHI GROUP OF BUILDERS, INC.** with business address at **Lalud, Calapan City, Oriental Mindoro**.

b) To recommend to the Provincial Government of Oriental Mindoro, represented by the Provincial Governor, to enter into a contract with **SANLAHI GROUP OF BUILDERS, INC.** for the **Repair/Rehab of Old Provincial Hospital Main Ward Building (Designated Quarantine Area) for COVID-19 Patients and PUI's/PUM's at Ilaya, Calapan City, Oriental Mindoro (1.) Installation of Drywall Partitions; 2.) Fab./ Installation of Double Deck; 3.) Installation of Laboratory Sinks; 4.) Installation of Electrical Lightings & Fans)** at a contract price equivalent to **ONE MILLION NINE HUNDRED EIGHTY THOUSAND FOUR HUNDRED FIFTY EIGHT PESOS AND 15/100 (Php 1,980,458.15)**.
