CONTRACT AGREEMENT

THIS AGREEMENT, made this May 14, 2020 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA PhD**, Provincial Governor hereinafter called the "ENTITY" and **SANLAHI GROUP OF BUILDERS, INC.** with office address at Lalud, Calapan City, Oriental Mindoro represented by **FERNANDO C. SUZARA**, President, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Repair/Rehab of Old Provincial Hospital Main Ward Building (Designated Quarantine Area) for COVID-19 Patients and PUI's/PUM's at Ilaya, Calapan City, Oriental Mindoro**, hereinafter called "the Works, and the ENTITY has accepted the Bid for the amount of **ONE MILLION NINE HUNDRED EIGHTY THOUSAND FOUR HUNDRED FIFTY EIGHT PESOS AND 15/100 (Php 1,980,458.15)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - A. Bidding Documents for the Contract
 1. Drawings/Plans
 2. Specifications
 3. Approve Budget for the Contract
 - B. Notice of Award of Contract and the Contractor's "Conforme" thereon.
 - C. Net Financial Contracting Capacity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
