**CONTRACT AGREEMENT**

**THIS AGREEMENT**, made this JAN 20 2020 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **MARCPHIL CONSTRUCTION** with office address in Roxas, Oriental Mindoro represented by **MARCIANO M. DIMAPILIS**, Proprietor, hereinafter called the "CONTRACTOR".

**WHEREAS**, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Seawall at Masaguisi, Bongabong, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION NINE HUNDRED SEVENTY NINE THOUSAND EIGHT HUNDRED FIVE PESOS AND 10/100 ONLY (Php 1,979,805.10)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**
