CONTRACT AGREEMENT

THIS AGREEMENT, made this JAN 5 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camiimil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and KASANGA CONSTRUCTION & SUPPLIES with office address at Bayanan I, Calapan City, Oriental Mindoro represented by ROMEL B. DEINLA, General Manager, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Sitio Ilaya, Water, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FOUR HUNDRED SEVENTY SEVEN THOUSAND SIX HUNDRED FIFTY SIX PESOS AND 97/100 ONLY (Php 1,477,656.97) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
