CONTRACT AGREEMENT

THIS AGREEMENT, made this JAN 13 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and F.S SUGAY CONSTRUCTION & SUPPLIES with office address in Mahogany St. Sto. Niño, Calapan City, Oriental Mindoro represented by FRANCILITA S. SUGAY, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Sitio Pagturian, Brgy. Villaflor, Puerto Galera, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED TWENTY SEVEN THOUSAND SIX HUNDRED TWENTY FIVE PESOS AND 63/100 ONLY (Php 1,927,625.63) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
