CONTRACT AGREEMENT

THIS AGREEMENT, made this FEB 07 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and CMSEL CONSTRUCTION AND DEVELOPER with office address at Masipit, Calapan City, Oriental Mindoro represented by MARIETA T. MADERAZO, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Brgy. Burbuli, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION SIX HUNDRED EIGHTY TWO THOUSAND SIX HUNDRED TWENTY SEVEN PESOS AND 22/100 ONLY (Php 1,682,627.22) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
