CONTRACT AGREEMENT

THIS AGREEMENT, made this FEB 28 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RM SESCAR ENTERPRISES with office address at San Mariano, Roxas, Oriental Mindoro represented by RIZALITO M. SESCAR, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Multi-Purpose Building for SADAKASS at Zone-I, Socorro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION TWO HUNDRED SEVENTY EIGHT THOUSAND EIGHT HUNDRED SEVENTY SIX PESOS AND 65/100 ONLY (Php 1,278,876.65) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
