CONTRACT AGREEMENT

THIS AGREEMENT, made this FEB 28 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RM SESCOAR ENTERPRISES with office address at San Mariano, Roxas, Oriental Mindoro represented by RIZALITO M. SESCOAR, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Open Canal at Sitio Lanzones, Barangay Calingag, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FOUR HUNDRED FIFTY THREE THOUSAND FOUR HUNDRED TWENTY THREE PESOS AND 09/100 ONLY (Php 453,423.09) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
