CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 06 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RJJJ ENGINEERING SERVICES with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by JOHN CROMWELL D. RECTO, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair/ Rehabilitation of Provincial Road and Drainage Canal @ Sitio Holy Spirit and Sitio Pulong Niyogan, Brgy. Barcenaga, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FIVE MILLION NINE HUNDRED FIFTY TWO THOUSAND NINE HUNDRED FIFTY SEVEN PESOS AND 36/100 ONLY (Php 5,952,957.36) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
