**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **Special Education Fund** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Classroom at Villa Cerveza High School, Victoria, Oriental Mindoro (Const. of 7.00m x 9.00m Conc bldg. w/ 0.40m embankment, Ceiling, Painting and Tileworks at C.R.);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-004-A) in PhilGEPS Website on **March 09, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Classroom at Villa Cerveza High School, Victoria, Oriental Mindoro (Const. of 7.00m x 9.00m Conc bldg. w/ 0.40m embankment, Ceiling, Painting and Tileworks at C.R.);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. 876 CONSTRUCTION & SUPPLY

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **March 09, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **March 09, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **876 CONSTRUCTION & SUPPLY** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **March 09, 2020** found out that bid price of **876 CONSTRUCTION & SUPPLY** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **876 CONSTRUCTION & SUPPLY** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **March 11, 2020**, thereby making its bid found to be responsive;
