CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 06 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MARC JILL CONSTRUCTION with office address Violet St., Lumangbayan, Calapan City, Oriental Mindoro represented by ENGR. ESTELA S. MACAPAGAL, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Multi-Purpose Building at Barangay Maidlang, Calapan City, Oriental Mindoro, Construction of Farm Tourism Structure at PDF Merit, Victoria, Oriental Mindoro and Repair/ Rehab of Day Care Center at Ordovilla, Victoria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount EIGHT HUNDRED THIRTY THREE THOUSAND TWENTY FOUR PESOS AND 36/100 ONLY (Php 833,024.36) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
