Construction of 2 Storey Bahay Kanlungan Building at Old Provincial Hospital, Calapan City, Or. Mindoro

1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% DF CA 2019 intends to apply the sum of Five Million Eight Hundred Forty Four Thousand Nine Hundred Eighty Six Pesos and 33/100 Only (Php 5,844,986.33) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of 2 Storey Bahay Kanlungan Building at Old Provincial Hospital, Calapan City, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for "Construction of 2 Storey Bahay Kanlungan Building at Old Provincial Hospital, Calapan City, Or. Mindoro". Completion of the Works is 142 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
