**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the 20% DF CA 2019 to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Road Section at Brgy. Pinagsabangan I- San Carlos, Naujan, Oriental Mindoro (Concreting of Road; PCCP: L of PCCP=255.00m; W of PCCP=4.00m; T of PCCP=0.23m; Thk201=0.20m; SHOULDER: Width BW=0.50m);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-017) in PhilGEPS Website on **February 17, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for **Concreting of Road Section at Brgy. Pinagsabangan I- San Carlos, Naujan, Oriental Mindoro (Concreting of Road; PCCP: L of PCCP=255.00m; W of PCCP=4.00m; T of PCCP=0.23m; Thk201=0.20m; SHOULDER: Width BW=0.50m);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. RJJJ ENGINEERING SERVICES

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **March 09, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, during the opening of Bid on **March 09, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **RJJJ ENGINEERING SERVICES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **March 09, 2020** found out that bid price of **RJJJ ENGINEERING SERVICES** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;
