CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 13 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and ADL CONSTRAK with office address at Bagumbayan, Roxas, Oriental Mindoro represented by ALEX D. LAQUI, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road Sitio Wawa (beside of Proper Bansud Elementary School) Brgy. Proper Bansud, Bansud, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY THREE THOUSAND ONE HUNDRED EIGHTY SIX PESOS AND 03/100 ONLY (Php 983,186.03) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
