RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the GF Cont'g 2018 to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Pathwalk at Sitio Upper Villareal, Socorro, Oriental Mindoro and Construction of Classrooms at Cacawan High School Pinamalayan, Oriental Mindoro**(Concreting of Pathwalk: L=14.00m; W=1.00m; thickness=0.15m; Const. of 7.00m x 9.00m Conc bldg. w/out flooring, embankment, Ceiling, Painting, Tileworks, Plastering Electrical, Plumbing, Septic Tank, Doors and Windows);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-030-A) in PhilGEPS Website on **May 23, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Concreting of Pathwalk at Sitio Upper Villareal, Socorro, Oriental Mindoro and Construction of Classrooms at Cacawan High School Pinamalayan, Oriental Mindoro**(Concreting of Pathwalk: L=14.00m; W=1.00m; thickness=0.15m; Const. of 7.00m x 9.00m Conc bldg. w/out flooring, embankment, Ceiling, Painting, Tileworks, Plastering Electrical, Plumbing, Septic Tank, Doors and Windows);

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. CMCS BUILDERS

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **June 3, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **June 3, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **CMCS BUILDERS** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
