**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
 (INFRASTRUCTURE)**

Resolution No. 042, Series of 2020

WHEREAS, there is an infrastructure project funded through the 20% GF CA 2019 to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Evacuation Center at Brgy. Laguna, Naujan, Oriental Mindoro (Construction of 12m x 8m evacuation center w/o footing tie beam, first floor slab, embankment, masonry works (for first floor) , painting works, tile works, ceiling works, canopy, septic tank, catch basin and with second floor slab, masonry works (for second floor), parapet walls, roofing works, electrical works (roughing in only), plumbing works (roughing in only for second floor), stairs, ramp and railings (for stairs only));**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-045) in PhilGEPS Website on **February 21, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for **Construction of Evacuation Center at Brgy. Laguna, Naujan, Oriental Mindoro (Construction of 12m x 18m evacuation center w/o footing tie beam, first floor slab, embankment, masonry works (for first floor) , painting works, tile works, ceiling works, canopy, septic tank, catch basin and with second floor slab, masonry works (for second floor), parapet walls, roofing works, electrical works (roughing in only), plumbing works (roughing in only for second floor), stairs, ramp and railings (for stairs only));**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. RJJJ ENGINEERING SERVICES

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **March 13, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, during the opening of Bid on **March 13, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **RJJJ ENGINEERING SERVICES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
