CONTRACT AGREEMENT

THIS AGREEMENT, entered into this 20th day of March 2020 between the PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, PHD, Provincial Governor hereinafter called the "FIRST PARTY" and BANCA ISYONG with office address at Tawiran, Calapan City, Oriental Mindoro represented by MR. LIMWELL BALITA, Owner, hereinafter called the "SECOND PARTY".

Motorboat rental including fuel and oil for the use of PHO-RESU Program in transporting specimen re: COVID19 Calapan to Batangas s in the amount of FOUR HUNDRED THOUSAND PESOS (Php 400,000.00) with the following agreement as follows:

1. That the Second Party will provide necessary facilities for the Motorboat rental including fuel and oil for the use of PHO-RESU Program in transporting specimen re: COVID19 Calapan to Batangas.
2. That the FIRST PARTY will pay the amount of Four Hundred Thousand Pesos (Php 400,000.00) from Health Services, Operations, Logistical/Technical Assistance Service, and Rent Expense of PHO.
3. That the SECOND PARTY will be the one to shoulder all expenses in terms of Motorboat rental including fuel and oil for the use of PHO-RESU Program in transporting specimen re: COVID19 Calapan to Batangas to be incurred during the pendency of the contract.
4. That in case of breakdown of facilities in the aforementioned date and event the SECOND PARTY will be the one to shoulder the cost of repair expenses without any additional charge from the FIRST PARTY for this purpose.
