CONTRACT AGREEMENT

MSSSD No. 114

THIS AGREEMENT, entered into this 12th day of November, 2019 between the PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MHA, PhD, Provincial Governor hereinafter called the "FIRST PARTY" and KDA LIGHT AND SOUND SERVICES with office address at Calapan City, Or. Mindoro represented by MR. JERWIN C. ABILAR, Owner, hereinafter called the "SECOND PARTY".

WHEREAS, the FIRST PARTY is desirous that the SECOND PARTY will provide rental of sound system set for use during the conduct of 2019 Palarong Pampaaralan at Bansud, Oriental Mindoro in the amount equivalent to ONE HUNDRED TWENTY THOUSAND PESOS (Php 120,000.00) with the following agreement as follows:

1. That the SECOND PARTY shall provide the sound system (mobile) and shoulder all expenses incurred for the installation and demobilization and replaced the defective sound system (mobile) if ever happen during the date and time of events without additional charge from the First Party for this purpose.
2. That the FIRST PARTY will pay the amount of One Hundred Twenty Thousand Pesos (Php 120,000.00) from the special education fund program, sports development program, provincial meet and rent expenses of PGO-EESD.
3. That the Second Party shall provide the sound system (mobile) and shoulder all expenses to and from the place of 2019 Palarong Pampaaralan at Bansud, Oriental Mindoro.
