CONTRACT AGREEMENT

THIS AGREEMENT, made this JAN 23 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and B.L. FLOR CONSTRUCTION with office address at 14 Daylily, Tandang Sora, Quezon City represented by BENJAMIN L. FLOR, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Sitio Bondoc, Brgy. Comunal, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED SEVENTY TWO THOUSAND ONE HUNDRED FIFTY FIVE PESOS AND 84/100 ONLY (Php 972,155.84) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
