Concreting of Sitio Bulago Road, Brgy. Palhi, Calapan City, Or. Mindoro

1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% DF CA 2019 intends to apply the sum of **One Million Four Hundred Fifty Eight Thousand Two Hundred Twenty Seven Pesos and 59/100 Only (Php 1,458,227.59)** being the approved Budget for the Contract (ABC) to payment under the contract for **"Concreting of Sitio Bulago Road, Brgy. Palhi, Calapan City, Or. Mindoro"**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for **"Concreting of Sitio Bulago Road, Brgy. Palhi, Calapan City, Or. Mindoro"**. Completion of the Works is **41 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

6. The PGOM will hold a **Pre-Bid Conference on February 28, 2020 at 9:00 a.m. at BAC Conference Room, Provincial Capitol Complex, Camilmil, Calapan City**, which shall be open to prospective bidders and interested parties.

7. Bids must be duly received by the BAC Secretariat, Capitol Complex, Camilmil, Calapan City, Oriental Mindoro on or before **March 09, 2020 at 8:30 a.m.** All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Claus 18.

Bid opening shall be on **March 09, 2020 at 9:00 a.m. at BAC Conference Room, Provincial Capitol Complex, Camilmil, Calapan City, Oriental Mindoro**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.

8. The PGOM reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
