CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 13 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RJJJ ENGINEERING SERVICES with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by JOHN CROMWELL D. RECTO, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Widening of Road at Sitio Upper, Proper I, Brgy. Campamento, Pola, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED FIFTY TWO THOUSAND EIGHT HUNDRED NINETY SEVEN PESOS AND 37/100 ONLY (Php 952,897.37) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
