THIS AGREEMENT, made this MAY 12 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and KASANGA CONSTRUCTION & SUPPLIES with office address at Bayanan I, Calapan City, Oriental Mindoro represented by ROMEL B. DEINLA, General Manager, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Solar Water System at Nag-iba I, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED SIXTY THREE THOUSAND FOUR HUNDRED FOUR PESOS AND 83/100 ONLY (Php 963,404.83) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
