THIS AGREEMENT, made this MAY 05 2020 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **MARC JILL CONSTRUCTION** with office address Violet St., Lumangbayan, Calapan City, Oriental Mindoro represented by **ENGR. ESTELA S. MACAPAGAL**, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Construction of Covered Court Bleachers at Sta. Brigida, Mansalay, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **THREE HUNDRED EIGHTY EIGHT THOUSAND EIGHTEEN PESOS ONLY (Php 388,018.00)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
