CONTRACT AGREEMENT

THIS AGREEMENT, made this MAY 18 2020 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and LINKS BUILDERS AND ENTERPRISES with office address San Vicente Central, Calapan City, Oriental Mindoro represented by ENGR. ERIC C. APASAN, Proprietor/Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Bleacher for Covered Multi-Purpose Building at Malinao, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FOUR HUNDRED NINETY SIX THOUSAND THREE HUNDRED SIXTY THREE PESOS AND 92/100 ONLY (Php 496,363.92) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
