CONTRACT AGREEMENT

THIS AGREEMENT, made this MAY 18 2020 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **LINKS BUILDERS AND ENTERPRISES** with office address San Vicente Central, Calapan City, Oriental Mindoro represented by **ENGR. ERIC C. APASAN**, Proprietor/Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Rehabilitation of Footbridge at Brgy. Caagutayan, San Teodoro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **TWO HUNDRED NINETY EIGHT THOUSAND SEVEN HUNDRED PESOS AND 30/100 ONLY (Php 298,700.30)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - F. PERT/CPM Diagram and bar chart with S-curve.
