(INFRASTRUCTURE)**

**WHEREAS**, there is an infrastructure project funded through the 20% DF 2019 SB #2 to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Road at Brgy. Malaya Naujan, Oriental Mindoro (Concreting of Road: PCCP: L of PCCP=100.00m; W of PCCP=3.00m; T of PCCP=0.23m; Thk 201=0.20m; no shoulder);**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-068) in PhilGEPS Website on **May 23, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Concreting of Road at Brgy. Malaya Naujan, Oriental Mindoro (Concreting of Road: PCCP: L of PCCP=100.00m; W of PCCP=3.00m; T of PCCP=0.23m; Thk 201=0.20m; no shoulder);**

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. B.L. FLOR CONSTRUCTION**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **June 3, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **June 3, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **B.L. FLOR CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
