**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
 (INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **General Fund Continuing Appropriation 2019** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Storage Building at Equipment Pool Division at Sta. Isabel, Calapan City, Oriental Mindoro (Construction of Storage Building w/ Embankment from Provincial Capitol; Masonry works height at 0.5m from ground line; Construction of pedestal and column; Installation of Roof and roof framing; w/o Doors, Windows and Dry Wall)**;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-070) in PhilGEPS Website on **May 23, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Storage Building at Equipment Pool Division at Sta. Isabel, Calapan City, Oriental Mindoro (Construction of Storage Building w/ Embankment from Provincial Capitol; Masonry works height at 0.5m from ground line; Construction of pedestal and column; Installation of Roof and roof framing; w/o Doors, Windows and Dry Wall)**;

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. B.L. FLOR CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **June 3, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, during the opening of Bid on **June 3, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **B.L. FLOR CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
