 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
 (INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **General Fund 2019 SB #2** to be undertaken by the Provincial Government of Oriental Mindoro for the **Rechanneling and Desilting of Miaje Creek at Brgy. Ipil, Bongabong, Oriental Mindoro (Rechanneling of River: Volume of Mixed sand, gravel, topsoil: 27,200.00 cu.m.)**;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-074) in PhilGEPS Website on **May 31, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Rechanneling and Desilting of Miaje Creek at Brgy. Ipil, Bongabong, Oriental Mindoro (Rechanneling of River: Volume of Mixed sand, gravel, topsoil: 27,200.00 cu.m.)**;

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. GEMWEALTH CONSTRUCTION AND TRADING CORP.

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **June 19, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **June 19, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **GEMWEALTH CONSTRUCTION AND TRADING CORP.** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
