**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
 (INFRASTRUCTURE)**

Resolution No. 077, Series of 2019

WHEREAS, there is an infrastructure project funded through the 20% Development Fund CA 2019 to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Multi-Purpose Hall at San Mariano, Roxas, Oriental Mindoro (Construction of 8 footings, 8 columns 4.55 mts. Height TB & FB connecting the columns and a perimeter Masonry from UP to FB);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-078) in PhilGEPS Website on **May 31, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Multi-Purpose Hall at San Mariano, Roxas, Oriental Mindoro (Construction of 8 footings, 8 columns 4.55 mts. Height TB & FB connecting the columns and a perimeter Masonry from UP to FB);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. RM SESCAR ENTERPRISES

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **June 19, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, during the opening of Bid on **June 19, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **RM SESCAR ENTERPRISES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **June 19, 2020** found out that bid price of **RM SESCAR ENTERPRISES** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **RM SESCAR ENTERPRISES** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **June 23, 2019**, thereby making its bid found to be responsive;
