**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the 20% DF CA 2019 SB#2 to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair/Rehabilitation of Drainage Canal at Casimiro St., Sitio Centro, Brgy. Poblacion II, Victoria, Oriental Mindoro (PCCP: L1=75m; W1=1.13m; Tkk=0.23m; t201=0.25m);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-079) in PhilGEPS Website on **May 31, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Repair/Rehabilitation of Drainage Canal at Casimiro St., Sitio Centro, Brgy. Poblacion II, Victoria, Oriental Mindoro (PCCP: L1=75m; W1=1.13m; Tkk=0.23m; t201=0.25m);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. MDH CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **June 19, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **June 19, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **MDH CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **June 19, 2020** found out that bid price of **MDH CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;
