INVITATION TO BID IB NO. CW 2020 – 079

Repair/Rehabilitation of Drainage Canal at Casimiro St. Sitio Centro, Brgy. Poblacion II, Victoria, Or. Mindoro

1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund CA 2019 intends to apply the sum of **One Million Four Hundred Sixty One Thousand Three Hundred Seventy One Pesos and 92/100 only (Php 1,461,371.92)** being the approved Budget for the Contract (ABC) to payment under the contract for "**Repair/Rehabilitation of Drainage Canal at Casimiro St. Sitio Centro, Brgy. Poblacion II, Victoria, Or. Mindoro**". Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for "**Repair/Rehabilitation of Drainage Canal at Casimiro St. Sitio Centro, Brgy. Poblacion II, Victoria, Or. Mindoro**". Completion of the Works is **82 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
