 (INFRASTRUCTURE)**

**WHEREAS**, there is an infrastructure project funded through the 20% DF CA 2019 to be undertaken by the Provincial Government of Oriental Mindoro for the **Installation of Box Culvert at the Boundary of Barangay Balinggayan and Malamig, Calapan, Oriental Mindoro (Const. of 1 Barrel Box Culvert: Box Culvert: L=6.00m; W =3.00m; Ht=3.00m; PCCP: L=103.00m; W=4.00m; t311=0.23m; t201=0.20m; (L=70.0m) shoulder=0.70m b/s; Concrete Shoulder: L=33.00m; W=0.70m b/s; thickness=0.23m; wheelguard 0.3x0.3x0.5);**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2020-080) in PhilGEPS Website on **May 31, 2020** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the the **Installation of Box Culvert at the Boundary of Barangay Balinggayan and Malamig, Calapan, Oriental Mindoro (Const. of 1 Barrel Box Culvert: Box Culvert: L=6.00m; W =3.00m; Ht=3.00m; PCCP: L=103.00m; W=4.00m; t311=0.23m; t201=0.20m; (L=70.0m) shoulder=0.70m b/s; Concrete Shoulder: L=33.00m; W=0.70m b/s; thickness=0.23m; wheelguard 0.3x0.3x0.5);**

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. B.L. FLOR CONSTRUCTION**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **June 19, 2020**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

**WHEREAS**, during the opening of Bid on **June 19, 2020** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **B.L. FLOR CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
