

Form of Performance Security	Amount of Performance Security (Equal to Percentage of the Total Contract Price)
1. Cash or cashier's/manager's check issued by a Universal or Commercial Bank.	Goods and Consulting Services Five percent (5%)
2. Bank draft/guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank: Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank.	Infrastructure Projects Ten Percent (10%)
3. Surety bond callable upon demand issued by a surety or Insurance company duly certified by the Insurance Commission as authorized to issue such security.	Thirty percent (30%)

The Provincial Government of Oriental Mindoro shall likewise enter into Contract within the same non-extendible ten (10) day period PROVIDED that the Performance Security and/or other documentary requirements are complied with. Failure of your office to post the Performance Security and sign the contract within the same ten (10) day period shall result in the following:


1. Forfeiture of the bid security;
2. Cancellation of award of contract;
3. Disqualification from participating in the bidding at hand;
4. Upon determination of administrative liability through blacklisting proceedings, it will suffer the corresponding penalty of suspension.
