**Improvement of Evacuation Center at Libertad, Roxas, Oriental Mindoro and
Completion of Evacuation Center at Orcunoma, Bongabong, Oriental Mindoro**

1. The **Provincial Government of Oriental Mindoro (PGOM)** through the **General Fund – 5% LDRRMF** intends to apply the sum of **Five Hundred Ninety Five thousand Three Hundred Fifty One Pesos and 82/100 Only (Php 595,351.82)** being the approved Budget for the Contract (ABC) to payment under the contract for **“Improvement of Evacuation Center at Libertad, Roxas, Oriental Mindoro and Completion of Evacuation Center at Orcunoma, Bongabong, Oriental Mindoro”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for **“Improvement of Evacuation Center at Libertad, Roxas, Oriental Mindoro and Completion of Evacuation Center at Orcunoma, Bongabong, Oriental Mindoro”**. Completion of the Works is **35 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
