WHEREAS, there is a project to be undertaken "by administration" for the **Repair/Rehabilitation of Oriental Mindoro Southern District Hospital Roxas, Oriental Mindoro (Partial Renovation of Main Building) (Painting of Ceiling and Walls and Installation of Floor Tiles) Complete Renovation of Governor's Office** by which the labor component of this project shall be undertaken through the Pakyaw Contracting System (Pakyaw Labor Group) by the Provincial Government of Oriental Mindoro;
