WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. GS-2020-063-A) in PhilGEPS Website on **June 23, 2020** and posted in the Provincial Capitol Complex, Bulletin Board Camilmil, Calapan City on even date for the of **Supply & Delivery of Construction Materials and Supplies for use in the Installation of Free Flowing at Dulangan I, Baco/ Installation of Deepwell at Malinao, Naujan Oriental Mindoro/ Installation of Free Flowing at Sitio Aliso & Sitio Bayug, Canubing II Calapan City, Oriental Mindoro/ Installation of Free Flowing at Barangay Poblacion II, Victoria Oriental Mindoro/ Installation of Deep Well at Dangay Roxas for the PGOM;**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder** purchased corresponding bid documents;

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at **10:00 a.m of June 30, 2020**, the proceeding was in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;
