CONTRACT AGREEMENT

MSSSD No. 141

THIS AGREEMENT, entered into this 11th day October 2019 between the PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, PHD Provincial Governor hereinafter called the "FIRST PARTY" and PARANG BEACH RESORT with office address at Parang, Calapan City, Oriental Mindoro represented by MS. CHELSA D. SEECHUNG, Resort Supervisor, hereinafter called the "SECOND PARTY".

WHEREAS, the FIRST PARTY is desirous that the SECOND PARTY will provide the packaged deal (catering services/accommodation/venue) for official use of ENRO in the conduct of Training Mangrove/Beach Forest Conversation and Rehabilitation within the Province of Or. Mindoro on 16-18 october 2019 at Calapan City, Oriental Mindoro in the amount of ONE HUNDRED SEVENTY FIVE THOUSAND FIVE HUNDRED PESOS (Php 175,500.00) with the following agreement as follows:

- 1. That the Second Party will provide necessary facilities for the packaged deal (catering services/accommodation/venue) for official use of ENRO in the conduct of Training Mangrove/Beach Forest Conversation and Rehabilitation within the Province of Or. Mindoro on 16-18 october 2019 at Calapan City for the Province of Oriental Mindoro.
2. That the FIRST PARTY will pay the amount of One Hundred Seventy five Thousand Five Hundred Pesos (Php 175,500.00) from the Operations, Natural Resources Management Services and Training Expenses of ENRO.
3. That the SECOND PARTY will be the one to shoulder all expenses in terms of packaged deal (catering services/accommodation/venue) for official use of ENRO in the conduct of Training Mangrove/Beach Forest Conversation and Rehabilitation within the Province of Or. Mindoro on 16-18 october 2019 at Calapan City, Or. Mindoro to be incurred during the pendency of the contract.
4. That in case of breakdown of facilities in the aforementioned date and event the SECOND PARTY will be the one to shoulder the cost of repair expenses without any additional charge from the FIRST PARTY for this purpose.
