CONTRACT AGREEMENT

THIS AGREEMENT, entered into this **26th** day of **September 2019** between the **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, PhD.**, Provincial Governor hereinafter called the "FIRST PARTY" and **VENCIO'S GARDEN HOTEL & RESTAURANT** with office address at Tawiran, Calapan City, Oriental Mindoro represented by **MS. MAYVEL ORTEGA**, Manager, hereinafter called the "SECOND PARTY".

WHEREAS, the FIRST PARTY is desirous that the SECOND PARTY will provide the catering services with accommodation to be consumed in the conduct of training on rice Processing of Agro Technology Resource Management Services Division on October 01-03, 2019 at the Regional Food Innovation Center, MINS CAT Campus at Calapan City, Oriental Mindoro in the amount of **SIXTY ONE THOUSAND NINE HUNDRED FIFTY PESOS (Php 61,950.00)** with the following agreement as follows:

1. That the Second Party will provide necessary facilities for the catering services with accommodation to be consumed in the conduct of training on Rice Processing of Agro Technology Resource Management Services Division on October 01-03, 2019 at the Regional Food Innovation Center, MINS CAT Campus at Calapan City for the Province of Oriental Mindoro.
2. That the FIRST PARTY will pay the amount of Sixty One thousand Nine Hundred Fifty Pesos (Php 61,950.00) from the Agricultural Services Operations, Agro-technology Resource Mgt. Services, Value Addition of Agric'l Commodities in Or. Mindoro and Training Expenses of PAGO.
3. That the SECOND PARTY will be the one to shoulder all expenses in terms of the catering services with accommodation to be consumed in the conduct of training on Rice Processing of Agro Technology Resource Management Services Division on October 01-03, 2019 at the Regional Food Innovation Center, MINS CAT Campus at Calapan City, Or. Mindoro to be incurred during the pendency of the contract.
4. That in case of breakdown of facilities in the aforementioned date and event the SECOND PARTY will be the one to shoulder the cost of repair expenses without any additional charge from the FIRST PARTY for this purpose.
