



**BAC RESOLUTION RECOMMENDING TO THE HOPE THE AWARD OF INFRASTRUCTURE CONTRACT**

**Resolution No. 054, Series of 2020**

**WHEREAS**, there is an infrastructure project funded through the **Supplemental Budget No. 2 for FY 2020** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Isolation Building for COVID-19 Patients and PUI's/PUM's at Oriental Mindoro Southern District Hospital, Roxas, Oriental Mindoro (Construction of Isolation Building (7m x 9.7m); w/ removal of existing pathway; Embankment of 1m; Masonry and plaster works on perimeter walls, CR, shower Room, ramp and stair sides; roof and roof framing works; ceiling works; dry walls; Installation of doors and windows; tileworks at building's floor, CR and shower Room's floor and walls; plumbing and electrical works; with painting; Construction Of parapet walls (1.3m height); construction of ramp and stair; installation of ramp And stair railings);**

**WHEREAS**, **GPPB Circular 01-2020** allows the BAC to negotiate with contractors with proven legal, technical and financial capacity to undertake procurement of infrastructure projects through Negotiated Procurement (Emergency Cases);

**WHEREAS**, during negotiations, **ADL CONSTRAK** has submitted a formal written offer (Bill of Quantities) for the above mentioned project in the amount of **THREE MILLION FOUR HUNDRED EIGHTY NINE THOUSAND FOUR HUNDRED SEVENTY NINE PESOS AND 08/100 (Php 3,489,479.08)** and duly executed OSS For Emergency Procurement under Republic Act No. 11469 otherwise known as the "Bayanihan to Heal as One Act";

**WHEREAS**, **GPPB Circular 01-2020**, allows the BAC to immediately recommend award of contract to one that has legal, technical, and financial capacity to undertake the construction of the aforementioned infrastructure project;

**WHEREAS**, **GPPB Circular 01-2020**, allows the submission of mandatory documents after award of contract, but before payment;

**WHEREAS**, **ADL CONSTRAK** is a contractor known to possess legal, technical, and financial capacity to undertake the construction of the aforementioned project at the soonest possible time;

**NOW, THEREFORE, BE IT RESOLVED**, as it is hereby **RESOLVED**:

a) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro to award the aforementioned project to **ADL CONSTRAK** with business address at **Bagumbayan, Roxas Oriental Mindoro**.

b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor to enter into a contract with **ADL CONSTRAK** for the **Construction of Isolation Building for COVID-19 Patients and PUI's/PUM's at Oriental Mindoro Southern District Hospital, Roxas, Oriental Mindoro (Construction of Isolation Building (7m x 9.7m); w/ removal of existing pathway; Embankment of 1m; Masonry and plaster works on perimeter walls, CR, shower Room, ramp and stair sides; roof and roof framing works; ceiling works; dry walls; Installation of doors and windows; tileworks at building's floor, CR and shower Room's floor and walls; plumbing and electrical works; with painting; Construction Of parapet walls (1.3m height); construction of ramp and stair; installation of ramp And stair railings) at a contract price equivalent to THREE MILLION FOUR HUNDRED EIGHTY NINE THOUSAND FOUR HUNDRED SEVENTY NINE PESOS AND 08/100 (Php 3,489,479.08).**
