**Completion of Evacuation Center at Mayabig, Baco, Oriental Mindoro**

1. The **Provincial Government of Oriental Mindoro (PGOM)** through the **20% Development Fund-5% LDRRMF- SB # 1** intends to apply the sum of **Four Hundred Ninety Seven Thousand Nine Hundred Eighty Seven Pesos and 81/100 Only (Php 497,987.81)** being the approved Budget for the Contract (ABC) to payment under the contract for **“Completion of Evacuation Center at Mayabig, Baco, Oriental Mindoro”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for **“Completion of Evacuation Center at Mayabig, Baco, Oriental Mindoro”**. Completion of the Works is **33 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
